# 7. Public Hearing regarding Resolution 10-2023 adjusting the rates for Ambulance Services

Chief Sedgwick presented this item. Back in June of 2019, Chief Schwartz brought to the Board Ordinance 03-2019 establishing ambulance transport rates which passed. This ordinance also established a mechanism to adjust those rates every year based on the same rates of the CPI by a Resolution of the Board during a Public Hearing. The District has not adjusted the ambulance rates since 2019.

North Tahoe Fire continues to provide excellent ALS service at a great value to our constituents. The District is asking the Board to adopt Resolution 10-2023 to increase the ambulance rates by 4.05% which reflects the percentage change in the CPI specific to ambulance transports. The District will still be providing this service at a lower cost than 10 other SSV providers and almost \$1000 below average. Our El Dorado County ALS service billing is controlled by the County and those rates are higher than ours.

Chief Leighton presented this item to the Board. Next Thursday, June 1<sup>st</sup>, Chief Leighton, Chief Armstrong, and Director Eason have a Zoom meeting scheduled with the representatives from Placer County and El Dorado County to get some momentum going for the annexation process.

This morning, Chief Leighton received the Goodwin Consulting Group's financial impact analysis that was commissioned by Placer County. He has not had the chance to dig deep enough into it to report on anything.

At the last Meeks Bay Board meeting the Board concluded that they are going to write letters, either individually or as a Board, to El Dorado County to state their desire to keep the annexation process going.

There potentially is an option for El Dorado County to ask El Dorado LAFCO to dissolve Meeks Bay Fire District and take control of the organization, which proposes an opportunity for North Tahoe Fire to contract with El Dorado County to provide fire protection in that area, similar to the way it provides fire protection with Alpine Meadows. The District can also continue to have the Board take the action to be at-large members through LAFCO. Kim has some emails to CalPERS to see if El Dorado County dissolves Meeks Bay Fire District are they responsible for the UAL, and if that is the case El Dorado County can do what they want with the UAL.

This item was for informational purposes. No Board action was required, but there was a discussion between Board and staff. There was no public comment.
