RESOLUTION NO. 10-2023
TO INCREASE EXISTING RATES FOR AMBULANCE SERVICES

WHEREAS, on June 19, 2019, the North Tahoe Fire Protection District approved Ordinance No. 03-2019 which indicated that:

1. The Schedule of Fees for services and supplies, attached hereto as Exhibit "A" and incorporated herein by reference, is hereby amended and adopted as the rates to be charged for ambulance, rescue, interfacility transfers and first aid services and supplies by the District.
2. The fees identified in Exhibit "A" of Ordinance 03-2019 shall be adjusted annually, beginning July 1, 2019 and each July thereafter, by the percentage change in the Consumer Price Index (CPI) for "All Urban Consumers" for the U.S. City Average for medical care, not seasonally adjusted (1982-84 = 100) as published by the United States Department of Labor, Bureau of Labor Statistics, as published for the twelve (12) month period ending December 31 of the preceding calendar year, except that no CPI adjustment shall reduce any fees.
3. Approval by the Board of Directors shall be by resolution, adopted at a regularly scheduled meeting of the Board prior to enactment of the increase.

NOW THEREFORE IT BE RESOLVED by the Board of Directors that:

1. The fees identified in Exhibit "A" are being adjusted effective July 1, 2023 pursuant to Ordinance 03-2019, by the percentage change in the Consumer Price Index (CPI) for "All Urban Consumers" for the U.S. City Average for medical care, not seasonally adjusted (1982-84 = 100) as published by the United States Department of Labor, Bureau of Labor Statistics, as published for the twelve (12) month period ending December 31 of the preceding calendar year, except that no CPI adjustment shall reduce any fees.

**ORDINANCE 03-2019
OF THE
NORTH TAHOE FIRE PROTECTION DISTRICT**

**AN ORDINANCE SUPERSEDING AND REPLACING ORDINANCE 01-2016
INCREASING EXISTING RATES FOR AMBULANCE SERVICES AND
SUPPLIES**

WHEREAS, NORTH TAHOE FIRE PROTECTION DISTRICT is a Fire Protection District duly organized and existing under the Fire Protection District Law of the State of California; and

WHEREAS, the District is authorized by the provisions of Health & Safety Code Section 13862 to operate an ambulance service within and without the District and to operate rescue and first aid services within and without the District;

WHEREAS, the Board of Directors of North Tahoe Fire Protection District has determined that it is necessary to provide advanced life support (ALS) ambulance service within the legal boundaries of the District.

WHEREAS, the Board of Directors of North Tahoe Fire Protection District has determined to adopt ALS billing District-wide as a matter of policy.

WHEREAS, the District pursuant to Health & Safety Code Section 13916 deems it necessary to charge and occasionally increase certain charges related to ambulance transports.

NOW, THEREFORE, BE IT ORDAINED by the Board of Directors of NORTH TAHOE FIRE PROTECTION DISTRICT that;

1. The Schedule of Fees for services and supplies, attached hereto as Exhibit "A" and incorporated herein by reference, is hereby amended and adopted as the rates to be charged for ambulance, rescue, interfacility transfers and first aid services and supplies by the District.
2. The fees identified in Exhibit "A" shall be adjusted annually, beginning July 1, 2019 and each July thereafter, by the percentage change in the Consumer Price Index (CPI) for "All Urban Consumers" for the U.S. City Average for medical care, not seasonally adjusted (1982-84 = 100) as published by the United States Department of Labor, Bureau of Labor

Statistics, as published for the twelve (12) month period ending December 31 of the preceding calendar year, except that no CPI adjustment shall reduce any fees.

Approval by the Board of Directors shall be by resolution, adopted at a regularly scheduled meeting of the Board prior to enactment of the increase.


3. This Ordinance shall take effect and be in force from and after its approval required by law, until it is amended, suspended, and/or rescinded by this Board.
4. If any fee, word, or provision of this Ordinance, including Exhibit "A", is found by a court of competent jurisdiction to be invalid, then the offending portion shall be severed from the remaining provisions of this Ordinance, which shall remain in full force and effect.
5. This Ordinance accordingly is adopted at the June 19, 2019 meeting, with the new rates to be effective thirty days thereafter.
6. This Ordinance 03-2019 supersedes and replaces Ordinance 01-2016 in its entirety.
